PART 1 - PREPARING FOR YOUR FEDERAL FIRE/LIFE SAFETY RECERTIFICATION SURVEY

- Identify steps your organization can take, both on an ongoing basis and at the time your survey window opens, to prepare for your survey.
- List the steps your organization needs for successful survey preparation one to two days before the survey occurs.
- Recognize the importance of having a comprehensive life safety plan and up-to-date building life safety floor plan drawings that can be shared with a surveyor upon request.
- Describe the contents of a comprehensive survey manual to assemble that has all the required documents, reports and records.
- Take home ideas and best practices to prepare for a successful survey.

PART 2 & 3 - TOP K-TAGS, #10 - 1

- Become familiar with the top 10 K-Tags in Minnesota care centers so you know which areas to evaluate, monitor and prioritize for compliance.
- Hear what the state fire marshals are citing in their inspections to identify areas to target for immediate improvement or confirm your continued compliance.
- List the checks and inspections you need to do annually to meet life safety requirements and discuss operational approaches for ensuring they happen.
- Explore successful interdisciplinary team approaches to preserving compliance with life safety/fire codes.
