ERIN HILLIGAN – Chair (First, one-year term)



Erin Hilligan is Vice President of Operations for Ebenezer in Minneapolis, a faith-based, multi-site organization and affiliate of M Health Fairview. Prior to serving in that role, she was the Corporate Director of Skilled Services for two years and previously was the campus administrator at Ebenezer Ridges in Burnsville for 14 years where she oversaw the operations of the full continuum including memory care, adult day, child care, HUD independent living, assisted living and skilled care.

Erin served as Secretary-Treasurer of the LeadingAge Minnesota Board of Directors for two years and Chair-Elect for two years. She also served four years as a Board-appointed director-at-large and has a long history of service on committees and work groups including the Integrated Service Delivery/Managed Care, Survey Review and Analysis, SNF Regulatory Committees, Care Center Cabinet, Nominating Committee and the LeadingAge National Public Policy Committee. With 30 years of experience in senior care services, Jerry's strength and knowledge includes mission-focused governance, financial and operational oversight, organizational repositioning, service expansion and diversification, quality processes, strategic planning, and new project and program development.
