The arrival of the pandemic brought many changes and additions to federal and state laws on unemployment compensation for workers in health care settings including changes to employees' eligibility criteria and the effect of paid benefits on your unemployment costs. This webinar will update and refresh your knowledge of this complex set of laws and how you can best address challenges in unemployment claims
