#### ERIN HILLIGAN – Chair (Second, one-year term)



Erin Hilligan is Vice President of Operations for Ebenezer in Minneapolis, a faith-based, multi-site organization and affiliate of M Health Fairview. Prior to serving in that role, she was the Corporate Director of Skilled Services for two years and previously was the campus administrator at Ebenezer Ridges in Burnsville for 14 years where she oversaw the operations of the full continuum including memory care, adult day, child care, HUD independent living, assisted living and skilled care.
